Nominations must be made and seconded from the floor by members of the Washington, D.C. Metro Taxi Operators Association in good standing, other than the nominee, and seconded by a member of the Washington, D.C. Metro Taxi Operators Association in good standing, other than the nominee.

**ALL NOMINATIONS AND SECONDS SHALL BE SUBMITTED ORALLY FROM THE FLOOR.**

**NOMINEES MUST ACCEPT NOMINATION IN PERSON AT THE TIME MADE OR IN WRITING VIA CLEARLY WRITTEN, DATED AND SIGNED COMMUNICATION RECEIVED BY TEAMSTERS LOCAL 922, 2120 BLADENSBURG ROAD N.E., SUITE 102, WASHINGTON, D.C. BY END OF DAY FRIDAY, JANUARY 24, 2014**

After a candidate has accepted nomination, he or she may not, under any circumstance, revoke his or her acceptance after the ballots are printed.

**ONLY MEMBERS OF THE WASHINGTON, D.C. METRO TAXI OPERATORS ASSOCIATION IN GOOD STANDING WILL BE ALLOWED TO PARTICIPATE IN THE SPECIAL MEMBERSHIP MEETING TO NOMINATE LEADERSHIP COUNCIL CANDIDATES.**

Potential candidates are advised to verify, in advance of the nomination meeting, the eligibility of themselves and their nominators and seconders. Nominators, Seconders and Nominees will be considered in good standing with 2 months of dues payments confirmed. Any back dues must be paid prior to January 25, 2014 to be considered in good standing.

**To be eligible to be nominated for a Leadership Council position, you must be a member in good standing of the Washington, D.C. Metro Taxi Operators Association and must be a full time metered driver. You cannot have a business or professional relationship in an industry**

that is in competition with the metered taxi cab industry that could create a conflict of interest as a Leadership Council member.

## **ELECTION**

The election of (8) Leadership Council positions for the Washington, D.C. Metro Taxi Operators Association will be conducted by mail ballot. Ballot packets will be mailed to the last known provided address of all members of the Washington, D.C. Metro Taxi Operators Association on or about February 5, 2014. **All completed ballots must be received back at the designated Post Office Box by 10:00 a.m. on Wednesday, February 26, 2014 to be counted.**

Members who have not received a ballot by February 12, 2014, should call Teamsters Local 922 at 202-526-9250 to request a duplicate ballot. Duplicate ballots may be requested through February 19, 2014.

Instructions for the completion of the ballot will be enclosed in the ballot package. This is a secret ballot vote. You should mark your ballot in private and mail your ballot, sealed in the secret ballot envelope, to the designated post office box in the postage paid Business Reply envelope provided. Do Not Give Your Ballot to Anyone.

CANDIDATES OR THEIR AGENTS CANNOT COLLECT VOTED MAIL BALLOTS.

To be eligible to vote in this election you must be a member in good standing of the Washington, D.C. Metro Taxi Operators Association with 3 months dues paid through February 2014. Members have until 3:00 pm on February 25, 2014 to pay their dues at Teamsters Local 922, 2120 Bladensburg Road N.E., Suite 102, Washington, D.C. in order to have their votes counted.
