Route Changes

A. Temporary

Other than the period of November 15th through January 15th if a bid area is changed fifty percent (50%) or more, the employee shall have the right to 1st, follow the portion in excess of fifty percent (50%) of the stops, 2nd, bump most junior bid route or 3rd, become a swing driver.

If the temporary change involves more than a two-way split, the driver shall 1st, select by seniority, 2nd, bump most junior bid route or 3rd, become a swing driver.

B. Permanent

If, during the life of this Agreement, a driver's bid area is permanently changed by fifty percent (50%) or more of the total stops, start time change of more than one (1) hour or a change of fifty percent (50%) or more of the area or loop, they shall have the right to follow whichever portion of their bid area they desires or they will have the option to bump a junior driver in accordance with local seniority practices. This procedure shall be repeated a second (2nd) and third (3rd) time with the fourth (4th) move being assigned.

It is understood, the above provision does not apply to the period of November 15^{th} through January 15^{th} .

In centers where drivers bid on delivery areas, the bid shall contain a geographic description of the area or loop and identify the base line. It is understood that day-to-day adjustments may be made. The above language shall also apply to full-time combination jobs.
